- Call to order** Meeting was called to order at 4:25 pm

 - [AB 273 \(Aguiar-Curry\)](#) – Child Care Services: Eligibility – *Additional letter of support to be submitted this week. Bill is now in the Senate Appropriations Committee.*
 - [AB 60 \(Santiago and Gonzalez\)](#) – Subsidized Child Care and Development Services: Eligibility Periods – *Bill was incorporated as part of the 2017-2018 State Budget as a trailer bill and approved.*
 - [Promoting Affordable Childcare for Everyone Act \(PACE Act\)](#) – *Updates from Congressman Jared Huffman’s office will be shared at the upcoming Commission’s General Meeting*
